Huron River Fest Jr. Queen's Pageant Rules

- Contestants must be entering the fifth through eighth grade.
- All contestants should reside in Huron School District.
- Contestants must not be married or have been married; must not have born a child; must not be pregnant. A Jr. Queen or court member who becomes pregnant must give up their title.
- Contestants must be available and willing to fulfill the responsibilities of the Huron River Fest Jr. Queen.
- Jr. Queen and the court will be expected to attend the Huron River Fest on a daily basis and be on time to scheduled events. You will be asked to reign over the festival and help at various events.
- The length of the reign is one year. You will be asked to attend numerous festivals, fairs, and parades throughout the year to promote the festival; You will also help to plan the following year's Royalty Brunch.
